11. That the school shall be closed or permitted to be closed only from the

date which summer vacation is declared.

12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.

That the society shall provide fire safety measures in the school as per

the No Objection Certificate.

14. The management informed that no thatched roof accommodation is allowed to run the School.

15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students

16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.

17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.

The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
